CONSOLIDATION ORDER

IN RE THE CONSOLIDATION OF THE IDLEDALE FIRE PROTECTION DISTRICT, THE LOOKOUT MOUNTAIN FIRE PROTECTION DISTRICT, AND THE MT. VERNON FIRE PROTECTION DISTRICT, JEFFERSON COUNTY, COLORADO

The Petition having been filed by the Foothills Fire Protection District pursuant to § 32-1-603(3), C.R.S., and the Court having reviewed the petition and finding that the petition complies with the statutory requirements, and being otherwise fully advised

ORDERS pursuant to § 32-1-603(4), C.R.S.:

1. The consolidated district shall be known as the Foothills Fire Protection District ("Consolidated District"). The description of the Consolidated District is attached hereto as Exhibit A and incorporated by this reference.

2. Names and addresses of the board of the Consolidated District are as follows:

3. Conditions that attach to the Consolidated District of services: None, except as specifically set forth herein.

4. Description of the specified services to be provided by the Consolidated District: fire protection, ambulance and emergency medical and rescue services as described in the Service Plan.

5. The court approves the bonds of the directors attached to the petition.

6. The terms of the Preconsolidation Order are incorporated in this Order by reference, and the Agreement is attached as Exhibit B hereto.

7. Assets of the Consolidated District: The Consolidated District shall become the owner of and entitled to receive, hold, sue for, and collect all monies, funds, taxes, levies, assessments, fees and charges and all property of any kind or nature owned, leased, or claimed by or due to any of the consolidated Districts, including but not limited to the Facilities, all real and personal property and any interest therein, easements, licenses, permits, equipment, vehicles, furniture, plans, specifications, programs, systems, records, supplies, investments, securities, contracts, accounts, deposits, and all other tangible and intangible property (herein referred to as "Assets"). The Consolidated District shall succeed to all rights, title and interests in the Assets by operation of law. To the extent so required, the Consolidated District shall, on behalf of each District, transfer title to the Assets owned by each District to and into the name of the Consolidated District by appropriate deed, bill of sale, assignment or other instrument necessary to effect such transfer.

8. Pension Funds of Consolidated District: The Consolidated District shall, by operation of law, be the successor and assign of the volunteer firefighter pension fund of each District and shall provide for the election of persons to serve as trustees of the consolidated volunteer firefighter pension fund pursuant to Section 31-30-1107, C.R.S. The Consolidated Board shall cause the trustees of the volunteer firefighter pension fund of each District to establish uniform disability, retirement, survivor, and funeral benefits for all fire department members effective as of the date of the Court Order, which shall be no less beneficial than the 1996 benefits of the volunteer firefighter pension plan of Lookout Mountain, subject to compliance with all statutory requirements; provided that the retirement benefits of all retired fire department members of each District as of the date of the Court Order shall not be increased to any extent.

9. General Obligation Indebtedness and Liabilities of Consolidated District: All outstanding general obligation indebtedness of each District shall remain the legal obligation of the District which incurred such indebtedness on or before the consolidation of the Districts. The Consolidated District shall automatically incur a multiple-fiscal year financial obligation to impose a mill levy of not less nor more than eight (8) mills on all taxable property within the Consolidated District from 1997 and thereafter. Said 8-mill levy shall be adjusted, from time to time, if and in the event there is a change in the statutory or constitutional methodology or percentage used in calculating assessed valuation of real or personal property. Additionally, the 8-mill levy may be reduced in tax year 2009 and thereafter, after payment and discharge of Idledale's outstanding general obligation indebtedness.

The revenues generated from such eight (8) mill levy shall be utilized as follows:

a. First, to the operations and maintenance expenses of the Consolidated District in an amount not to exceed Two Hundred Forty Thousand Dollars (\$240,000) in any one fiscal year, which amount shall be adjusted from time to time to reflect changes in the U.S. Bureau of Labor Statistics Consumer Price Index, all items, all consumers, for the Denver-Boulder metropolitan area.

b. Second, to the annual debt service requirements of Idledale's existing general obligation bonds. The Consolidated District shall be required to impose an additional mill levy of not more than 1.582 on the taxable property within Idledale's boundaries in tax years 1997 and 1998 for the purpose of generating sufficient revenues to make required payments on Idledale's existing general obligation bonds.

c. Last, to the other lawful purposes of the Consolidated District.

Except as hereinafter provided and as provided in the Resolution authorizing the issuance of the existing Idledale General Obligation Bonds, no separate property tax will be levied in either District to pay such indebtedness.

Mountain Vernon, Lookout Mountain and Idledale have imposed upon all taxable property within their respective boundaries the 8-mill levy and Idledale has imposed the additional 1.582 mill levy hereinabove described for tax collection year 1997.

Pursuant to Section 32-1-607, C.R.S., and in accordance with this Court Order, all other obligations, debts, notes, accounts and

liabilities of any kind or nature of each District shall be assumed by and become the responsibility of the Consolidated District by operation of law.

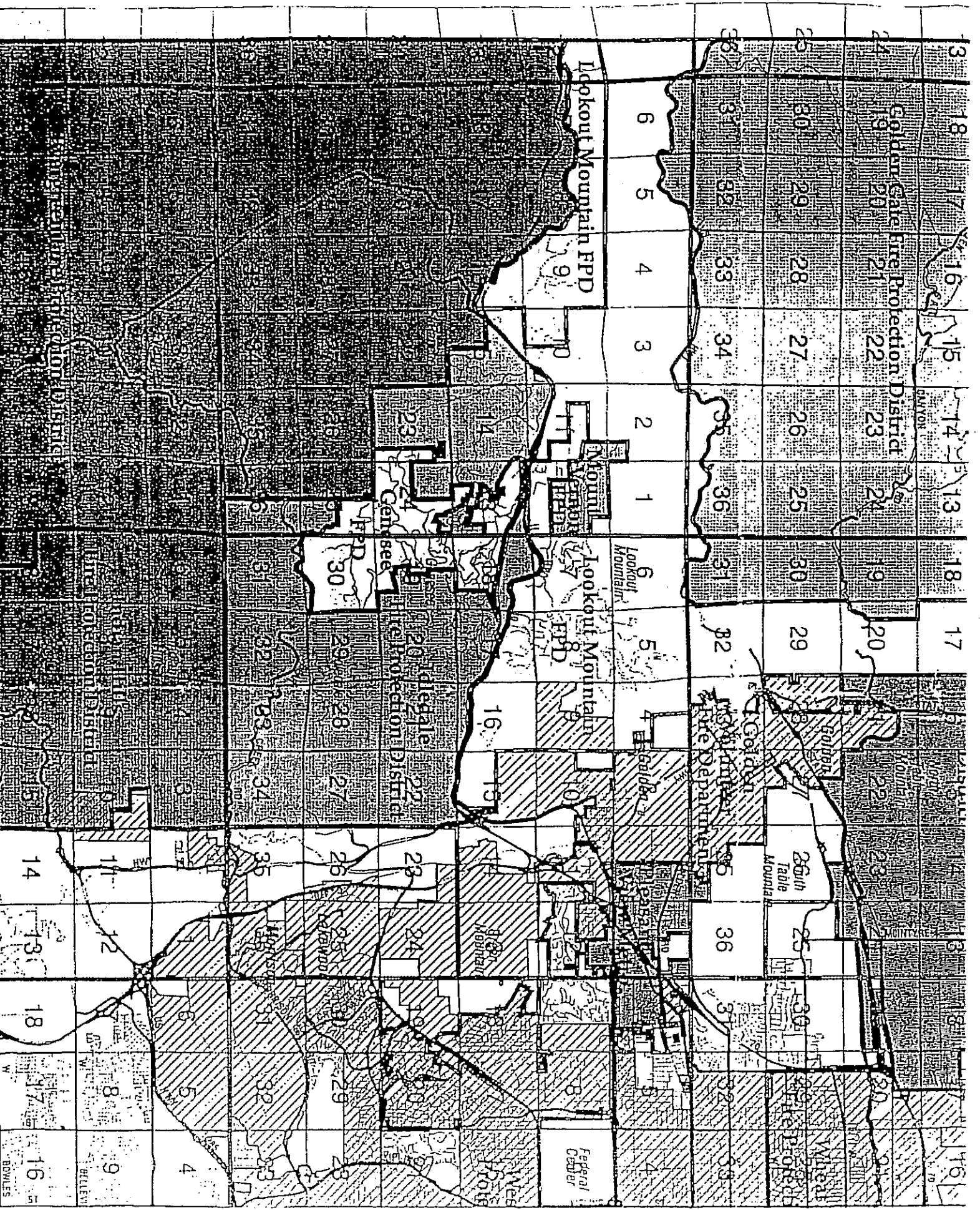

PRECONSOLIDATION AGREEMENT

THIS PRECONSOLIDATION AGREEMENT (hereinafter referred to as "Agreement") is made and entered into as of this 21<sup>st</sup> day of June, 1996, between and among the LOOKOUT MOUNTAIN FIRE PROTECTION DISTRICT (hereinafter referred to as "Lookout Mountain"), the IDLEDALE FIRE PROTECTION DISTRICT (hereinafter referred to as "Idledale") and the MOUNT VERNON FIRE PROTECTION DISTRICT (hereinafter referred to as "Mount Vernon").

WHEREAS, each of Lookout Mountain, Idledale and Mount Vernon (hereinafter individually sometimes referred to as a "District" and collectively referred to as "Districts") is a special district and a quasi-municipal corporation of the State of Colorado located in the County of Jefferson organized under the provisions of Title 32, Article 1, C.R.S. (hereinafter referred to as "Act"); and

WHEREAS, the Districts provide fire protection, ambulance and emergency medical and rescue services within their jurisdictional areas and own, operate, and maintain vehicles, equipment, property, and improvements (hereinafter collectively referred to as "Facilities") in connection therewith; and

WHEREAS, the Districts have common boundaries; and

WHEREAS, the Districts have cooperated with each other in the provision of mutual aid and related fire services through intergovernmental agreements; and

WHEREAS, the Board of Directors of each District has determined that a consolidated district may be operated effectively and economically and that the consolidation of the Districts in accordance with the Act and subject to the terms and conditions set forth herein will serve a beneficial public use and will promote the health, safety, prosperity, security and general welfare of the inhabitants of each District.

NOW, THEREFORE, in consideration of the mutual covenants, agreements and undertakings set forth herein, Lookout Mountain, Idledale and Mount Vernon agree to continue the statutory consolidation process, to consolidate the Districts pursuant to the provisions of Part 6 of the Act, and to implement such consolidation in accordance with and subject to the following terms and conditions:

1. Purpose of Preconsolidation Agreement. The terms and conditions set forth herein are integral and necessary elements of the agreement to consolidate the Districts and shall become part of and incorporated into the Court Order of consolidation entered pursuant to Section 32-1-603(4), C.R.S. (hereinafter referred to as "Court Order"). The approval and execution of this Agreement by each District are prerequisite conditions of proceeding with the consolidation of the Districts.

2. Purpose of Consolidation. The purpose of this consolidation is to consolidate Lookout Mountain, Idledale and Mount Vernon and all of the services provided by each District into a single consolidated district. It is the intent of each District that all operations, Facilities, assets and liabilities (except as otherwise provided herein) of the Districts be assumed by and become the property of the consolidated district.

3. Name of Consolidated District. The name of the consolidated district shall be Lookout Idledale Fire Protection District (the "Consolidated District").

4. Services of Consolidated District. The Consolidated District shall have all rights, powers and authorities granted to a fire protection district pursuant to the Act. The Consolidated District shall continue to furnish fire protection, ambulance and emergency medical services to, and to operate, maintain, replace, improve and enlarge the Facilities for the benefit of, all persons and property within the boundaries of the Consolidated District.

5. Boundaries of Consolidated District. The area to be included in the boundaries of the Consolidated District shall be all of the area originally contained within the organizational order of each District and the area contained in all inclusions into each District, excluding therefrom the area contained in all exclusions from each District, in effect as of the date of the Court Order.

6. Board of Consolidated District. The Board of Directors of the Consolidated District (the "Consolidated Board") shall have five (5) members to be elected at large within the boundaries of the Consolidated District. There shall be no director districts, as defined in Section 32-1-603, C.R.S., in the Consolidated District. The first Consolidated Board shall be composed and have terms as follows:

If there is a vacancy for any reason among the Directors designated herein for the Consolidated Board on or before the Court Order, the organizational Board of the Consolidated District, as defined in the Act (the "Organizational Board"), shall select one of its members (from the District represented by such designee, if possible) to fill such vacancy until the next election of Directors. Any Director of either District not designated herein for the Consolidated Board (as of the date of the Court Order) may,

at his option, act, and be compensated (on an equal basis with the Directors so designated) as an advisory member of the first Consolidated Board until such time as the term of office for which such Director was originally elected has expired.

7. Consolidation Election. The consolidation election in each District shall be conducted on the regular election date in November 1996.

Lookout Mountain, Idledale and Mount Vernon shall each present the ballot questions and issues identified in Exhibit A attached hereto and incorporated herein by this reference (hereinafter referred to as "Ballot Questions") to their respective electors at the consolidation election.

If the Ballot Questions are approved by the electors of Lookout Mountain, Idledale and Mount Vernon the Organizational Board of the Consolidated District shall determine the amount of bonds for each Director and the Treasurer of the Consolidated Board and shall, within sixty (60) days of the consolidation elections, petition the Court for the final order of consolidation in accordance with the terms and conditions set forth herein and the provisions of the Act. The Organizational Board shall request that this Agreement shall become a part of the terms and conditions of the consolidation set forth in the Court Order, and that this Agreement shall be binding upon the Consolidated Board. If the Ballot Questions are not approved by the electors of all three Districts at the consolidation election, this Agreement and the consolidation proceedings shall terminate on the day which is sixty (60) days after the date of the consolidation election ("Termination Date") unless, prior to the Termination Date, the Boards of both Districts have adopted resolutions to continue with proceedings to consolidate the Districts.

The parties agree that the district manager for Lookout and Idledale will coordinate and conduct the elections for Lookout, Idledale and Mount Vernon.

8. Assets and Liabilities of Each District. Lookout Mountain represents and warrants to Idledale and Mount Vernon that Exhibit B attached hereto and incorporated herein by this reference contains an accurate list of all assets and liabilities of Lookout Mountain existing as of the date hereof, inclusive of contract rights and obligations, and accurately describes all liens, pledges or encumbrances attached to or affecting any assets or properties of Lookout Mountain. Idledale represents and warrants to Lookout Mountain and Mount Vernon that Exhibit C attached hereto and incorporated herein by this reference contains an accurate list of all assets and liabilities of Idledale existing as of the date hereof, inclusive of contract rights and obligations, and accurately describes all liens, pledges or encumbrances attached to or affecting any assets or properties of Idledale. Mount Vernon

represents and warrants to Lookout Mountain and Idledale that Exhibit D attached hereto and incorporated herein by this reference contains an accurate list of all assets and liabilities of Mount Vernon existing as of the date hereof, inclusive of contract rights and obligations, and accurately describes all liens, pledges or encumbrances attached to or affecting any assets or properties of Mount Vernon. Except for Idledale's outstanding general obligation bonds, Lookout Mountain, Idledale and Mount Vernon each represent and warrant to the other that it has sufficient unrestricted funds available to timely pay and discharge, as the same become due and payable, all currently existing financial obligations of Lookout Mountain, Idledale and Mount Vernon respectively. Each District shall, upon request by the other District, deliver copies of executed contracts, agreements, invoices, etc. for purposes of verifying the information contained within Exhibits B, C and D hereto.

9. Assets of Consolidated District. Pursuant to Section 32-1-607, C.R.S., the Consolidated District, in accordance with the Court Order, shall become the owner of and entitled to receive, hold, sue for, and collect all monies, funds, taxes, levies, assessments, fees and charges and all property of any kind or nature owned, leased, or claimed by or due to either District, including but not limited to the Facilities, all real and personal property and any interest therein, easements, licenses, permits, equipment, vehicles, furniture, plans, specifications, programs, systems, records, supplies, investments, securities, contracts, accounts, deposits, and all other tangible and intangible property (herein referred to as "Assets"). The Consolidated District shall succeed to all rights, title and interests in the Assets by operation of law. Unless otherwise agreed by all Districts, each District shall maintain unrestricted cash reserves in the approximate amount shown on its audited financial statement for the fiscal year ending December 31, 1995, except: (i) to pay for regular, budgeted costs of operation and the purchase of assets to be owned by the Consolidated District, or (2) to acquire assets to be owned jointly by the Districts in the event the consolidation is not approved by the electorate or until the consolidation of the Districts and the transfer of Assets to the Consolidated District. To the extent so required, on or before the Court Order each District shall transfer title to the Assets owned by it to and into the name of the Consolidated District by appropriate deed, bill of sale, assignment or other instrument necessary to effect such transfer.

10. Pension Fund of Consolidated District. Pursuant to Section 32-1-607, C.R.S., the Consolidated District, in accordance with the Court Order, shall, by operation of law, be the successor and assign of the volunteer firefighter pension fund of each District and shall provide for the election of persons to serve as trustees of the consolidated volunteer firefighter pension fund pursuant to Section 31-30-1107, C.R.S. The Organizational Board

shall cause the trustees of the volunteer firefighter pension fund of each District to establish uniform disability, retirement, survivor, and funeral benefits for all fire department members effective as of the date of the Court Order, which shall be no less beneficial than the current benefits of the volunteer firefighter pension plan of Lookout Mountain, subject to compliance with all statutory requirements; provided that the retirement benefits of all retired fire department members of each District as of the date of the Court Order shall not be increased to any extent.

11. General Obligation Indebtedness and Liabilities of Consolidated District. All outstanding general obligation indebtedness of each District shall remain the legal obligation of the District which incurred such indebtedness on or before the consolidation of the Districts. It is the intent and agreement of the Districts that the Consolidated District shall incur a multiple-fiscal year financial obligation to impose a mill levy of not less nor more than eight (8) mills on all taxable property within the Consolidated District for collection in 1997 and thereafter, as stated in the Ballot Questions. Said 8-mill levy shall be adjusted, from time to time, if and in the event there is a change in the statutory or constitutional methodology or percentage used in calculating assessed valuation of real or personal property. Additionally, the 8-mill levy may be reduced in tax year 2009 and thereafter, after payment and discharge of Idledale's outstanding general obligation indebtedness.

The revenues generated from such eight (8) mill levy shall be utilized as follows:

a. First, to the operations and maintenance expenses of the Consolidated District in an amount not to exceed Two Hundred Forth Thousand Dollars (\$240,000) in any one fiscal year, which amount shall be adjusted from time to time to reflect changes in the U.S. Bureau of Labor Statistics Consumer Price Index, all items, all consumers, for the Denver-Boulder metropolitan area.

b. Second, to the annual debt service requirements of Idledale's existing general obligation bonds. Lookout Mountain, Idledale and Mount Vernon acknowledge and agree that the Consolidated District shall be required to impose an additional mill levy of not more than 1.582 on the taxable property within Idledale's boundaries in tax collection years 1997 and 1998 for the purpose of generating sufficient revenues to make required payments on Idledale's existing general obligation bonds.

c. Last, to the other lawful purposes of the Consolidated District.

Except as hereinafter provided and as provided in the Resolution authorizing the issuance of the existing Idledale General Obligation Bonds, no separate property tax will be levied in any District to pay such indebtedness.

If the consolidation has been approved by the electors of each District but for any reason the Court Order is not entered or obtained prior to December 15, 1996, Lookout Mountain, Idledale and Mount Vernon each covenant and agree to impose upon all taxable property within their respective boundaries the 8-mill levy and Idledale shall impose the additional 1.582 mill levy hereinabove described for tax collection year 1997.

Pursuant to Section 32-1-607, C.R.S., in accordance with the Court Order, all other obligations, debts, notes, accounts and liabilities of any kind or nature (herein referred to as "Liabilities") of each District shall be assumed by and become the responsibility of the Consolidated District by operation of law. After the date of this Agreement, no District shall incur substantial Liabilities (other than regular, budgeted costs of operation) without the approval of the other two Districts.

12. Rates, Fees and Charges of Consolidated District. Upon the consolidation of the Districts, the fees and charges then in effect in Lookout Mountain for services provided and charged for by both Districts shall become the fees and charges for such services of the Consolidated District. The fees and charges for services currently in effect in only one District shall become the fees and charges for such services of the Consolidated District. Such fees and charges may be subsequently amended or modified by the Consolidated Board.

13. Certain Interim Matters. Lookout Mountain, Idledale and Mount Vernon acknowledge and agree that the volunteer firefighters and other personnel who provide services on behalf of the Districts are actually members, officers and/or directors of fire departments organized within each District (the "Fire Departments"). Lookout Mountain, Idledale and Mount Vernon acknowledge and agree that for ease of administration and other reasons, it is in their respective best interests to have the Consolidated District served by only one such fire department. Therefore, Lookout Mountain, Idledale and Mount Vernon agree to:

a. Cooperate with each other and with the Fire Departments to address issues regarding merger, dissolution and/or the combination of one or both of the Fire Departments; and

b. Cause the Fire Departments, on or before January 1, 1997, to jointly select the fire chief and all other officers of the fire department to serve the Consolidated District and adopt a set of Standard Operating Procedures to govern the operation and other administrative functions of such consolidated fire

department. Only if the fire chief is not selected by the Fire Departments by January 1, 1997, then the Consolidated Board shall appoint the fire chief, the appointed fire chief shall appoint the subordinate officers, and the officers shall adopt the Standard Operating Procedures. Should the fire chief be selected by such date, but no subordinate officers selected or Standard Operating Procedures adopted, the Consolidated Board may appoint the subordinate officers or adopt the Standard Operating Procedures.

Lookout Mountain, Idledale and Mount Vernon shall each cause the prospective manager for the Consolidated District to promptly investigate the availability and pricing of and obtain price quotes for all insurance requirements of the Consolidated District so that all required coverages will be in place no later than the effective day and time of the consolidation of the Districts.

14. Effective Date. This Agreement shall be in full force and effect and be legally binding upon each District upon the later to occur of adoption of consolidation and concurring resolutions or the execution of this Agreement by the Boards of each District. Each District agrees to execute, approve and adopt any and all instruments, documents, rules and resolutions necessary to give effect to the terms of this Agreement.

15. Prior Termination. This Agreement may be terminated only in conformance with the express provisions hereof.

16. Default; Survival. In the event any one District, at any time during the term of this Agreement, fails to perform or comply with any provision of this Agreement, the remaining Districts shall provide written notice specifying the particular default and a reasonable time period for rectifying such default, and the responsible District shall correct such default within such reasonable time period. If the responsible District fails to correct such default within such time period, the remaining Districts may take such action as they deem proper or necessary to correct such default. The responsible District shall reimburse the remaining Districts for any expense incurred in correcting or enforcing such default, including attorneys' fees.

Lookout Mountain, Idledale and Mount Vernon each acknowledge and agree that certain of the terms, covenants and provisions of this Agreement require performance by the Consolidated District subsequent to the effectiveness of the consolidation and that the taxpayers of each of the respective Districts will be subject to harm and/or damages in the event of the failure of such performance. Therefore, Lookout Mountain, Idledale and Mount Vernon agree that:

a. Each of the terms, covenants and conditions hereof which contemplate or require performance subsequent to the effectiveness of the consolidation shall survive the effectiveness of such consolidation and shall not be merged therein.

b. Each taxpayer of the Consolidated District is hereby made a third-party beneficiary of the terms, covenants and conditions hereof to be performed subsequent to the effectiveness of consolidation and, in such capacity, shall have the right to seek and obtain such relief in the form of injunctive relief, contempt or mandamus as may be available or proper in the event of breach of the terms or covenants or failure of conditions. The prevailing party in any such proceeding shall be entitled to obtain, as part of its judgment, its reasonable costs of suit, including attorneys' fees.

17. Assignment. The Agreement shall not be assigned in whole or in part.

18. Amendment. This Agreement shall be amended, from time to time, or terminated by agreement between and among the Districts. No amendment, modification or alteration of this Agreement shall be binding upon the Districts unless the same is in writing and approved by the Boards of both Districts.

19. Waiver. Subject to the provisions of paragraph 16 hereof, no waiver by any District of any right, term or condition of this Agreement shall be deemed or construed as a waiver of any other right, term or condition, nor shall a waiver of any breach hereof be deemed to constitute a waiver of any subsequent breach, whether of the same or of a different provision of this Agreement.

20. Remedies. No remedy provided to any District shall be required to be exhausted or exercised as a prerequisite to any further relief to which it may then be entitled. Every obligation assumed by or imposed upon any District shall be enforceable by any appropriate action, petition or proceeding at law or in equity. This Agreement shall be construed in accordance with the laws of the State of Colorado.

21. Notices. All notices or approvals required under this Agreement shall be in writing and shall be hand delivered or sent by certified mail, return receipt requested to:

Any District by written notice provided to the other Districts may change the address to which future notices shall be sent. All notices so given shall be construed as effective when delivered.

22. Counterparts. This Agreement may be executed in multiple counterparts, each of which shall constitute an original, but all of which shall constitute one and the same document.

23. Entirety. This Agreement constitutes the entire agreement between and among the Districts concerning the subject matter herein, and all prior negotiations, representations, understandings or agreements pertaining to such matters are merged into and superseded by this Agreement. No representation, warranty or certification, express or implied, shall exist between the parties except as expressly set forth herein.

IN WITNESS WHEREOF, the Boards of Directors of Lookout Mountain, Idledale and Mount Vernon have approved and caused this Agreement to be executed on the day and year first above written.
