**A RESOLUTION OF THE FOOTHILLS FIRE PROTECTION DISTRICT TO ADOPT
THE FEE SCHEDULE DATED 2026-09-08**

WHEREAS, the Foothills Fire Protection District (“District”) is a quasi- municipal corporation and political subdivision of the State of Colorado operating pursuant to Article 1, Title 32, C.R.S., for the purpose of providing fire protection and emergency services; and

WHEREAS, Section 32-1-1002(1)(d), C.R.S., authorizes a fire protection district to adopt and enforce fire codes; and

WHEREAS, Sections 32-1-1001(j) and 32-1-1002(1)(e)(II) and (III), C.R.S., authorizes a fire protection district to fix and from time to time increase or decrease fees and charges for requested or mandated inspections if a fire code has been adopted; and

WHEREAS, the Board of Directors finds and determines that it is in the best interest of the residents, taxpayers, and visitors of the District to maintain adequate and updated District fees concerning inspections and plan review services requested of the District concerning fire and life safety by adoption of the attached Fee Schedule for such services

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF
THE FOOTHILLS FIRE PROTECTION DISTRICT THAT:**

1. Adoption of Fee Schedule

The Board of Directors of the Foothills Fire Protection District hereby adopts the Foothills Fire Protection District Fee Schedules attached hereto as Exhibit A (the “Fee Schedule”), establishing fees for requested sprinkler system, fire alarm, construction plan and other plan reviews and for underground hydrostatic tests, hood and duct system tests, spray booths, fireworks stands, and other inspections related to IFC regulations governing the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises in the District. The fees established in the Fee Schedule are hereby referred to, adopted and made a part hereof as if fully set forth in this Resolution. The Fee Schedule shall replace and supersede any prior fees approved and adopted by the Board.

2. Public Hearing

A public hearing on this Resolution was held on Tuesday, September 8, 2026 at 6:30 p.m., at the Foothills Fire Protection District.

3. Severability

If any part, section, subsection, sentence, clause or phrase of this Resolution or the Fee Schedule is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions. The Board of Directors hereby

declares that it would have passed and adopted this Resolution and the Fee Schedule and each part, section, subsection, sentence, clause or phrase thereof, should any other section, subsection, sentence, clause or phrase be declared invalid.

4. **Effective Date.** This Resolution shall take effect immediately upon its adoption.
